Maharashtra Scheduled Castes, Scheduled Tribes, De-notified Tribes (*Vimukta Jatis*), Nomadic Tribes, Other Backward Classes and Special Backward Category (Regulation of Issuance and Verification of) Caste Certificate Act, 2000.

No. SAKAA. 2016/C.R.127/AASTHA-2.—In exercise of the powers conferred by sub-section (1) of section 6 of the Maharashtra Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis), Nomadic Tribes, Other Backward Classes and Special Backward Category (Regulation of Issuance and Verification of) Caste Certificate Act, 2000 (Mah. XXIII of 2001) and in supersession of all previous Notifications issued in this behalf,the Government of Maharashtra hereby constitute the Scrutiny Committees as specified in the Schedule appended hereto, for verification of Caste Certificates issued by the Competent Authorities under sub-section (1) of section 4 of the said Act and specify its function and area of jurisdiction, as follows, namely:—

- 1. Each Scrutiny Committee shall consist of the following members, namely:-
- (a) Divisional Commissioner or Additional Divisional ... Chairperson;
  Commissioner (Revenue) or Collector or Additional
  Collector (I.A.S.) or Additional Collector (Selection Grade)
  or Joint Secretary of the State Government or Additional
  Commissioner, on the establishment of Social Justice
  Department or Officers not below the rank of Joint
  Secretary of the State Government
- (b) Deputy Commissioner (Social Welfare) or Regional
  Deputy Commissioner (Social Welfare) or Divisional
  Social Welfare Officer.
- (c) Assistant Commissioner (Social Welfare) or Special . . Member-District Social Welfare Officer or Research Officer. Secretary.
- 2. The area of the jurisdiction of each of the said Scrutiny Committee shall be as specified in column (4) of the Schedule appended hereto.
- 3. The Government directs all the Chairperson of the concerned Scrutiny Committee shall, after considering the workload of the Committee, specify the days in a week, on which the Committee shall work and shall take the hearing at least once in a week at the head quarter.
